Fund description

The fund invests directly or indirectly in 'investment grade' listed bonds issued by corporations in developed markets. Within the fund investments in euro, American dollar and British pound are permitted, with the maximum allowed weight of investments in American dollar and/or British pound being 20% of the aggregate value of the fund.

Aegon AM uses a structured multi-manager investment process for asset management. This means that on the basis of an intensive selection process, specialized external managers manage the assets.

Fund objective

To achieve an annualized outperformance of 0.5% over a full market cycle. The ex-ante tracking error is expected to be within a 0.25-2% range with a maximum of 4%.

Currency Risk

The currency risk of any investments in United States dollars and British pounds is hedged to the euro.

Dividends

The fund does not distribute dividends.

Fiscal status

There is tax transparency, which means the fund is not subject to corporate tax and the results on investments are directly attributed to the participants themselves.

Subscription and redemption

Participations are redeemable on a daily basis.

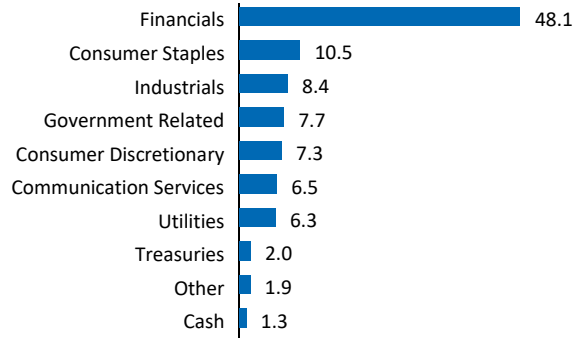

- Other general costs not included in the service fee will be charged to the fund and include but are not limited to: brokerage and custody fees, fees for proxy voting services and transaction costs.

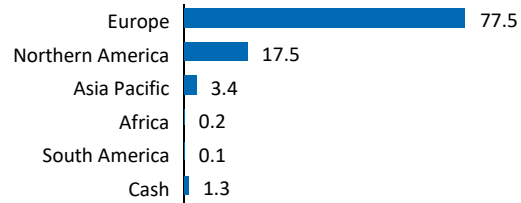

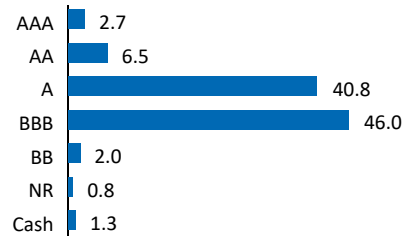
Sector distribution (%)
